

**Agreement on the limited liability for damage on mobile containers and equipment of the company ALGECO s.r.o.**

Dear customer,

During the lease of mobile containers there may occur some unpleasant situations, such as damage, theft or other damage event. By the signing of General terms and conditions the customers obliges itself, that it will return the subject of particular lease in the same condition as when it was received by such customer. Otherwise, the ALGECO shall bill expenses connected with the removal of damage and putting the subject of particular lease to its original condition. Expenses for the purchase of a residential container are in the scale from 100.000,- CZK to 150.000,- CZK + VAT and for sanitary containers, such amount may be up to 250.000,- CZK + VAT. The company ALGECO is offering to you the Agreement on the limited liability for damage on leased containers and equipment as the additional service and when such agreement is concluded, than you can prevent problems connected with the solving of unpleasant situations, such as burglary, fire, natural disasters etc.

**Advantages of our proposal:**

- low monthly fee
- limited impacts of damage solving
- simple liquidation of damage events

With respect to your needs, you may use one of four options for the liability for damage:

**ECONOMY – includes:**

- extreme weather (hail, flood, lightning, frost etc.)
- fire, short circuit

- The lessee is limiting its participation in the maximum amount of 25.000,- CZK / 1.000,- EUR / container + VAT (damage exceeding such above mentioned amount shall be paid by the company ALGECO itself).

**COMFORT – includes:**

- extreme weather (hail, flood, lightning, frost etc.)
- fire, short circuit
- theft of a container
- vandalism

- The lessee is limiting its participation in the maximum amount of 13 000,- CZK / 500,- EUR / container + VAT. (damage exceeding such above mentioned amount shall be paid by the company ALGECO itself).

**PREMIUM - includes:**

- extreme weather (hail, flood, lightning, frost etc.)
- fire, short circuit
- theft of a container
- vandalism
- burglary (it does not include items, which are not owned by the company ALGECO)
- all equipment rented by ALGECO

- The lessee is limiting its participation in the maximum amount of 0,- CZK / 0,- EUR / container + VAT. (damage exceeding such above mentioned amount shall be paid by the company ALGECO itself).

**FULL CUSTOMER'S LIABILITY**

- The lessee shall be fully liable for every occurred damage during the duration of its lease. Within 7 working days since the return of a container, there will be performed the check of the subject of particular lease and if there will be any damage, then the operating department of the company ALGECO will issue the estimate and an invoice for necessary repairs will be issued in compliance with such estimate.

**If you will not select any of the suggested options, than the company ALGECO shall have the right to charge the client according to the option COMFORT.**
